
History of the District



The Evergreen Park & Recreation District (originally named the Evergreen Metropolitan Recreation and Park District and renamed in 1992) was authorized in January 1969 by a vote of the residents of the area. At that time, the stated purpose of the District was to provide recreational opportunities to its residents and construct a community center with a swimming pool.

Parks

The Evergreen Park & Recreation District owns over 75 acres of parkland on 15 different parcels and partners with various other agencies in the management of approximately 180 additional acres on 7 additional parcels. Components of the Evergreen Park and Recreation District's managed park property include:

- Ball diamonds (5)
- Multipurpose fields (4)
- Open turf (1)
- Picnic grounds/shelters (8)
- Playgrounds (5)
- Tennis court locations (2)



Trails in the District

There are over 230 miles of hiking and biking trails within the boundaries of the Evergreen Park & Recreation District (EPRD), 6.45 miles of which are on EPRD property. The majority of these trails are owned and managed by other agencies.

Several types of trails exist, including natural trails and paved trails. Some trails are contained within the extent of individual parks, and some meander through the District and connect parks and open space to homes and businesses. Many of the trails are destination hikes and attract not only residents, but also users from outside of District boundaries.


EPRD Funding

- EPRD's 2022 appropriations are approximately \$13.5 million in total for the District.
- Approximately 31% comes from fees and charges for programs and facilities, 28% from property taxes and 28% from grant funding.
- Other funding comes from the Colorado Lottery, support from private foundations and other contributions.






EPRD 2022 Operational Expenditures (Audited)






EPRD 2022 Operations Revenue (Audited)

2022 Grants

In 2022 EPRD had its second-highest year ever for grants, *raising over \$1.6M in grant awards*.

- \$3,000 from Team Evergreen to support EPRD's Youth Mountain Biking Program;
- \$12,500 from the Colorado Department of Local Affairs to help keep Wulf Pool open and staffed;
- \$68,000 from Colorado Parks & Wildlife for bear-proof receptacles throughout Evergreen parks;
- \$142,191 from Colorado Department of Early Childhood to support childcare services, facilities, staff and families at Wulf Rec Center;
- \$400,000 from the Denver Regional Council of Gov'ts for the Evergreen Lake North Trail; and
- most significantly \$1,000,000 from Jefferson County Open Space Trails Partnership Program as finish-line funding to complete the Evergreen Lake North Trail.

EPRD is deeply grateful for these generous grants to help support programs and projects across our District.

- Rolled out new and highly successful summer concert series at the Lake House
- Resurfaced Evergreen Lake House parking lot
- Received grant for bear-proof trash cans to be installed district-wide in 2023
- Extended season for ice-skating due to early opening

- Tennis bench shade installation at Wulf courts
- ePact software and hardware purchased for licensed programs
- Successful public bidding for the construction of the Evergreen Lake North Trail
- Launch of the new EPRD Strategic Plan
- Trialed new surveillance system
- Began implementation of new building-wide internet access at Wulf
- Rolled out new cybersecurity systems and processes
- Created and hosted community volunteer cleanup days
- Lake House began using warming hut during skating season, and began offering bar space in the Lake House for rentals
